
2019 Floods & Breached Levees

March 2019

- Flooding on Niobrara (NE)
 Elkhorn (NE), Platte (NE),
 Missouri and Mississippi
 rivers (& their tribs)
- Breached levees in several counties
- Upriver of KC & STL hard hit

May/June 2019

- Recurrent severe flooding on Missouri and Mississippi rivers
- Breached several more levees in several more counties
- Downriver of Kansas City and upriver of St Louis hard hit








Acres Exposed by Breached Levees



2019 Floods & Breached Levees

- Rates Reflect Risk
- Risk changed for land behind a levee with new holes in it
- For the 2020 Crop Year, we need to account for that new risk and the possibility that the new risk will go away (holes will be fixed)



2019 Floods & Breached Levees Breached Levee Statement for 11/30 filed crops

Land flooded due to a breach in a levee resulting from prior year(s) flooding is insurable. The applicable rate will be assigned based on conditions of the levee and soils on the latter of the sales closing date or earliest planting date. If, by that date, the levee has not been repaired to prior specifications, or if damaged soil (if any) has not been restored to at least the same crop yield potential as prior to the flood event, the land will be classified as high-risk and will have the highest rate classification in the county. However, if the levee is repaired to prior design specifications, and the soil has at least the same crop yield potential as before the flood, the land will be classified as shown on the current crop year Actuarial Map. If the levee has been temporarily or permanently repaired, but not to prior design specifications, by the latter of the sales closing date or earliest planting date, and the soil has at least the same crop yield potential as before the flood, then RMA may adjust the rate to an amount consistent with the level of flood risk by written agreement, if applicable. For RMA to consider any levee repair, RMA must be provided a certification from the U.S. Army Corps of Engineers or signed and sealed certification from a professional engineer who is currently licensed and registered in the state where the levee is located. For soils to be considered restored to the same crop yield potential as before the flood, you must sign a statement that damaged soil (if any) has been restored to at least the same crop yield potential as prior to the flood event.

2019 Flood & Breached Levees Applying the Statement

- For any repair to a breached levee system, TRO must receive certification from the USACE or signed and sealed certification from a professional engineer who is currently licensed and registered in the state where the levee is located;
 - For levee systems under the USACE jurisdiction, TRO will be able to directly obtain a certification of the breached levee system repairs.
 - For private levee systems, the insured or the AIP will need to provide a signed and sealed certification from a professional engineer who is currently licensed and registered in the state where the levee is located.
- As SCD approaches, TRO will notify AIP's of breached levee status (and affected acreage)
 via Informational Memorandums
- For damaged soil (if any), the AIP will make the determination if damaged soils have been restored, which is done when processing a claim (if any)



2019 Flood & Breached Levees Applying the Statement - Temp Repairs

- The 11/30 statement allows for temporary/partial/interim repairs. Requirements:
 - RMA receives certification from USACE or
 - For private levees, a signed and sealed certification from a professional engineer who is currently licensed and registered in the state where the levee is located.
- RMA is currently working on a streamlined procedure "Blanket Offer Written
 Agreement" which will reduce paperwork burden for producers and AIPs:
 - Temporary/Partial/Interim repairs are completed by the Deadline.
 - RMA receives the new level of protection certifications.
 - No Written Agreement Requests required.
 - RMA will calculate a new rate and it will be issued through the Regional Office Exceptions (ROE) system.
 - These actions will likely occur by RMA in April.



2019 Flood & Breached Levees Applying the Statement

<u>Information needed from Private Engineer:</u>

- 1. The levee system name and location (county & the part of the county it is in)
- 2. The levee system has been repaired to prior specifications (Yes or No)
- 3. The levee system has been repaired to a temporary/permanent level of protection, but not to prior specifications (Yes or No)
- 4. The date the last breach repair was completed on the levee system.
- If temporary/permanent level of protection, but not to prior specifications, please provide the minimum overtopping height (In Feet based on River Gage Station) of the repaired levee system.

This information must be Signed & Sealed by a professional engineer that is licensed in the






2019 Floods & Breached Levees Example of a Breached Levee

Levee L-550 (Atchison Co. MO)

- Breached in March 2019
 - 30,000+ acres affected
- 7 breaches
 - USACE recently stated breaches have been closed.
 - But repairs are on-going
 - Expect certification on repairs and level of protection
- 6/30 Breached levee statement (fall planted crops)
- 11/30 Breached levee statement (spring planted crops)
- Rate behind levee will reflect the breach with the lowest level of protection, provided applicable Statement criteria has been met






^{*} Based on the certification from the USACE, the Elm Point Levee was temporarily repaired to the Level of Protection (LOP) it was prior to the levee breach. Therefore, for the 2020 crop year, the acreage behind the levee will carry the same map classification and subcounty rate it had prior to the levee breach. Please see the 2020 Actuarial Information Browser for the applicable map classification and subcounty rate



2019 Flood & Breached Levees Written Agreements

The Breached Levee statement does not prohibit an insured from submitting a written agreement (WA) request to our office. In general, there could be scenarios when an insured submits WA request, for instance:

- The insured disagrees with the determination his/her cropland acreage was flooded by a breached levee
- The insured disagrees with the high risk rate we assign based on a temporary/partial/interim repaired levee.
- If the levee has been repaired (fully, or temporary/partial/interim) <u>after</u> the stated deadlines, but <u>before</u> the insured plants the crop.
